Product Licensing Guide

Cayosoft Inc.

This Product Licensing Guide states the terms associated with licensing each Cayosoft product that you the "Subscriber" or "Licensee" or "Customer" have purchased.

Non-Hybrid Users	Any enabled Active Directory User object or iNetOrgPerson object (no matter the purpose, be it for a human, service account, application account etc...) that is not synchronized for use (not intended to be assigned a license with a mailbox) in an online platform such as Microsoft 365 (formerly Office 365) or Google GSuite in any Active Directory Domain or Azure Tenant being managed by the software. For example, where all enabled Active Directory objects are synchronized to Azure Active Directory and many of those users are not assigned a license that contains an Exchange Mailbox, they are considered Non-Hybrid.
Hybrid & Cloud Users	All enabled Azure Active Directory user objects (no matter the purpose, be it for a human, service account, application account etc...) that could access any Azure Active Directory resource or any Microsoft 365/Office 365 resource such as a mailbox or application, or 3 rd Party Azure Integrated Application in each tenant being managed by the software. The count of these users is determined by the Azure/Microsoft 365/Office 365/Microsoft 365 licensing available in each Microsoft Tenant being managed by the software. This license type includes Cloud Users and it includes Azure Guest Users.
Cloud Only Users	All enabled Azure Active Directory User objects or Guest object (no matter the purpose, be it for a human, service account, application account etc...) in each Microsoft Tenant being managed by the software.
Guest Users	Any "Guest" Users in Azure Active Directory (no matter what the use - humans, services, applications) in each Microsoft Tenant being managed by the software.
AD LDS Users	Any enabled Active Directory Lightweight Directory Service (AD LDS) User Object in the AD LDS Instance being managed by the software.
Enterprise	Software licenses by this license type may be used to manage an unlimited or specified maximum number of users in each of the specified Active Directory Domains or Microsoft Tenants owned by the purchasing organization. The scope of this license (unlimited or specified maximum) will be listed on the appropriate order form or invoice.
Azure/Microsoft 365 Licensed User	Any user account in Azure Active Directory that has a license assigned either through Azure or through Microsoft 365 (Formerly Office 365).
Test and Production	Cayosoft customers with a valid Cayosoft subscription and who are in compliance with Cayosoft Licensing requirements, can use their primary Production license in test and pre-test development environments as well.

This Product Licensing Guide may be amended from time to time by Cayosoft, provided, however, that the terms and conditions of this Product Guide that are in existence as of the date Cayosoft accepts an order placed by Subscriber or Licensee or Customer shall apply to the specific Software referenced in such order regardless of any changes that are subsequently made to this Product Licensing Guide.
